Staff have been split in to 4 teams for this period:

School based team. This is led by MB and KG

The staff timetable has been developed to match the number of staff in school to the no. of pupils and the needs of the pupils. Staffing structures are reviewed on a weekly basis as part of SLT and adapted.

Staff have worked through Easter holidays and Bank holidays to keep school open for pupils with EHCPs, the most vulnerable and the children of critical workers Safe Social Distancing for staff is a challenge. Pupils, especially the youngest and those with additional needs find this particularly difficult. Additional challenge where there are pupils with significant SEMH needs.

Numbers have fluctuated initially these were less than 5. Now pupils numbers are typically 15-18pupils. These are children of critical workers, pupils with an EHCP, Pupils with a social worker and pupils considered the most vulnerable.

GQ: A high proportion of staff are shielding/isolating. How was the risk assessment done and is there any movement on this? A concern is the burden falling on the same staff. A. The school is down to six teachers which is an issue. RC took advice on risk assessment at the time of initial closure and these rules have not so far been updated.

Governors discussed the implications of opening schools up in line with the government statement yesterday. RC advised that as class rooms are small there is likely to be a staggered and rolling programme offered for pupils. Perhaps mornings or afternoons and with smaller class sizes.

GQ: Are staff offered anything in terms of personal protection equipment (PPE)? A. Gloves and sanitiser are available for staff to use. Glove use is mixed as some staff find them uncomfortable. The school is now ordering further gloves sanitiser and also mask and aprons. There is a good awareness that staff need protection particularly with younger children who find social distancing difficult. There is also the issue of children finding the PPE frightening and this will need to be handled carefully and sensitively and points again to staggered opening, perhaps getting one group settled with the new system before inviting other pupils back. One way systems for pick up/ drop off also need to be considered.

GQ: Presumably guidance from NYCC will be forthcoming? A. Yes, RC will monitor this.

It is early days and a lot more guidance is required to help the school plan appropriately. It was agreed that once an approach is defined the Governors input will be useful. Once a plan is drawn up RC will share with Governors and ask for comments. It is likely this will need to happen before the next meeting on 6 June as schools are possibly opening up further on 1 June. Governors are mindful of the need to protect staff, especially staff who have worked through the last half term and need a break before 1 June. It may be that the school closes for the upcoming half term to allow for this break.

GQ: Is consideration been given to online lessons? A. This is happening but not for all year groups. Feedback from parents so far on pre-recorded on line lessons has been very positive. To the extent that consideration is being given to continuing this after coronavirus as it helps parents support their children's learning.

8.10 **Staffing Structure**

The revised staffing structure was circulated to all Governors prior to the meeting and RC highlighted the main issues. The model needed to be revised due to a number of issues including staff requests to alter hours and the projection of fewer children enrolling for nursery next year. So far nine prospective children have enrolled and the previous projection was for twenty four children. Several factors are likely to contribute to these figures including the new housing at the Keeble nursery end of town and that the nursery does not offer full wrap round care for working parents. Nursery hours are not 9 -6pm.

GQ: How does the new model fit with the budget? A. It has been designed to accommodate the anticipated budget. The school can no longer justify a separate

	GQ: What is the cost? A. The cost is £1200. GQ: Can it be shown that the school would have hit attainment targets had Coronavirus not interrupted the school year? A. It is impossible to say. The school would have been closer to the targets as significant improvements have been demonstrated. Governors agreed to continue with McKie Mastery GQ: Should we ask for a discount since we have not had a full year this year due to Coronavirus and potentially may not be able to undertake a full year next year? A. It is probably unlikely but RC will enquire. Ofsted RC confirmed that routine inspections are frozen, although Ofsted will continue to inspect where safeguarding issues are raised. It is therefore unlikely that an inspection will be scheduled before September 2020. EMS In answer to a GQ, RC advised that the decommissioning process of the EMS continues. There were no responses to the staff consultation.
