5.1	Welcome The Chair opened the meeting at 6.15pm, welcomed LM and GW as new Governors and thanked all Governors for attending.

5.3	Remind Governors about Declaration of Interest There were no declarations of interest at this point in the meeting.	
5.4	 Notification of any other urgent business June Wilson Deputy Head teacher has resigned and will leave on 14 February 2020. June hopes to call into the school before then. This is very sad, June will be a great loss to the school. The post is currently advertised on NYCC website. Shortlisting will take place on 30 Jan and interviews 10 Feb. RC asked for a governor to assist in the shortlisting and interviews along with DD. Jo Heddock has given notice. No replacement has been appointed at this stage. A pupil has begun the transition to another school. The move will take place in February.

5.9	McKie Mastery Update RC advised that Ofsted no longer examine Schools own data and in the light of that he has asked the senior leadership team (SLT) to present headline data and trends without too much detail. KS1 and KS2 SATS results will be produced. Governors would like to see the detailed data as Governors responsibilities are wider than Ofsted. RC is happy to upload this on to the shared drive. years and SLT members are that McKie mastery has had a wholly positive impact, in some areas dramatic. Impacts on learning behaviours are positive. Improvements are seen across SEN non SEN, pupil premium, free school meals and non free school meals children. Probably the more dramatic improvements are evident lower in the school. Staff are working hard with year 6 but it is the nature of such a significant shift that those who have had more time in the previous system are likely to take longer for the full benefits to be apparent.

Autumn Term Data and Analysis for Writing

LT circulated an updated action plan and highlighted the following:

Year 1

- Excellent progress is being made by all children.
- All groups are making expected progress, including SEN and PP
- 12-14% of children are being challenged at the year above. These children are achieving GDS and working at year 2 already.
- EAL making good progress
- At least 91% are expected to pass phonics test but the aim is100%

Year 2

- The majority of groups have made progress at a good standard. PP and SEN are lower.
- In this cohort girls are stronger than boys
- FFT50 likely to be met
- 14% of children at expected already
- Already most groups achieving higher than last year (approx. 6% up)

Year 3

- This group remain a need to watch
- Not near FFT50
- We are addressing a catch up plan for this group

Year 4

- A high number of pupils achieving GD in this cohort and working within year 5 standards (36%)
- PP is good, SEN still requires monitoring

Year 5

- Girls require further monitoring
- 14-15% now at GD for writing and working on year 6 expectations
- PP still low for this group at 50% but has increased by 12%
- SEN require further monitoring but all other groups are largely as expected or close to FFT50

GQ: Are SEN making Progress? A. Yes but it is the same issue as with year 4 of moving from the toolkit analysis to McKie Mastery. Evidence of progress is in the books but has not yet translated into the data. This should improve now we have the starting point benchmark for all.

Year 6

Realistically FFT50 is still an aspiration from a low starting point on entry.
 However gaps have been closed.

GQ: Is our target FFT50 or FFT 20? I understood we were aiming higher for FFT20). A.FFT 20 is ambitious. There is a mix through the year groups, while for some groups it does not look possible, we are striving for it for all children.

Autumn Term Data and Analysis for Reading

BW circulated an updated action plan and highlighted the following:

Year 1

- 68% of children achieved GLD at the end of EYFS.
- The current target is for 100% to achieve phonics screening, 97% have already scored the required pass mark.
- 100% SEN are on track

Year 2

- Children have made good progress
- Currently on track to better last years end state by 7%
- Within one pupil of achieving FFT50

Year 3

- End predictions look as though the cohort has declined but looking at the books that is not the case
- Non FSM outperform FSM by 50%
- There are still gaps in phonics for some children

Year 4

- 78% are on track to make age related expectation which is a 13% increase on last year
- Girls outperform boys but both have made strong progress

Year 5

- 78% on track for age related expectation which is 4% increase on last year
- 4 children working in the group above

Year 6

- 61% on track for age related expectation which is 3% increase on last year
- Non FSM outperform FSM
- · Girls outperform boys
- 7 children are in an early morning focus group booster session at 8.30

Autumn Term Data and Analysis for Maths

KG circulated an updated action plan and highlighted the following:

Year 1

- Target is for 81% to achieve at or above in maths
- Currently 97% are expected or on track so exceeding predictions
- 100% of both PPG and SEN are predicted to reach expected standard

Year 2

- 72% of this cohort reached the expected standard or higher at the end of year
- 81% are currently on track to do so. This is in line with FFT50
- 35% of pupils are on track to reach GD at the end of KS1 in comparison to 24% at the end of EYFS.

Year 3

- 65% of cohort are on track to meet expected standard in comparison to 60% at the end of Y2. This prediction is above the school target but 3% below FFT50
- Boys outperform girls

Year 4

- 72% are on track to meet expected standard. This is 7% below FFT50 target.
- There is no gap between PPG/non PPG

Year 5

- 61% reached age related expectation at the end of year 4
- Currently 94% of children are on track to reach age related expectation or higher. A 33% increase
- SEN pupils have made particularly good progress

Year 6

- Currently 75% are on track to reach age related expectation which is 8% higher than last years cohort. However our GD prediction remains significantly below national at 6%. National is 27%
- SEN and PPG have not made good progress
- Non PG, non SEN and EAL have made good progress

Autumn Term Data and Analysis for Reception and Nursery

MB circulated an updated action plan and highlighted the following:

• 65% of nursery pupils are on track in the prime areas to achieve 40-60E at the end of nursery

100% of PP have made typical progress or better across all prime areas			
 75% of girls and 56% boys are on track in the prime areas to achieve 40-60E 54% of reception pupils are currently on track for GLD (compared with 41% at this time last year) This is as a result of increased focus on literacy skills through McKie mastery teaching. 65% are on track for reading (compared with 54% in September) 65% are on track for writing (compared with 50% in September) Attainment of pupils who attended our nursery far exceeds that of pupils coming into reception from elsewhere. Our home grown pupils are taught quality early literacy skills. 			
The reports underlined to Governors that McKie mastery is the right approach and is working. Reading is a key priority and excellent progress has been made. Even where there is still catching up to be done, there is evidence of significantly improved learning behaviours which should reap benefits in the future. SEN progress in Maths is excellent. Some nursery children are working with reception which benefits and stretches them but also leaves smaller numbers and therefore greater depth for those in nursery. It also works the other way round. On behalf of the Governors DD thanked the SLT for their reports and the excellent progress.

5.13 Safeguarding / Child Protection including Attendance			
RC highlighted to Governors the child protection cases and safeguarding concerns in school. Attendance continues to be monitored closely. It is too early to ascertain whether the 'nudge' process is having an effect but figures are improved. Last week's attendance was 96%. PACE is being used. GQ: What is PACE? A. The process by which the local authority prosecute the parents or guardians of very poor attenders.
